

Not only does it store and organize valuable information, but it does so while increasing efficiency and eliminating systemic and data-centric redundancies. After all, you wouldn't invest in such a system if it didn't offer a robust array of functional tools to organize necessary tasks.

However, these systems can't do it all.

In fact, this is the very reason why you rely on third party software, like OpenWater, to manage tasks your current system can't. And while you can keep each system segmented, integration eliminates potential disasters, fees, and a healthy dose of frustration.

Taking the time to better understand integrations before proceeding with your own is the key to making the most of your integrated system. With that, let's discuss the most important question of all: why should you integrate?



# WHY INTEGRATE

Your Association Management System can do a lot. But, can it efficiently manage your awards program? Probably *not*.

This is why you turn to systems like OpenWater to fill in the gaps and keep your organization on track.

When you have an external need – like awards management– you can't turn to just any system. You need a system that meets all awards workflow requirements and that can be integrated with your existing AMS or CRM. But, why integrate?

Integration is vital for three main reasons:

- 1. Ease of use for entrants/applicants, particularly with login processes
- 2. Reduction in siloed data
- 3. Elimination of the need for external programs, like Excel, to bridge the gap between systems

Integration allows both systems to have an ongoing conversation and work together to automate tasks, reduce data redundancies and break down data siloes for better engagement and lower costs for your organization.

Now that you understand the inherent value of integration, it's important that you also learn *what* you can integrate should you choose to do so. Each of the four common integrations on the following page correlates to the reasons for/benefits mentioned above.

# WHAT TO INTEGRATE

### Single Sign-On (Login and Authentication + Member Status)

Single Sign-On (SSO) allows users – entrants, judges, committee members, and others alike - to use their existing username and password to sign in to your system. This eliminates the unnecessary step of creating a new profile just to enter an awards program or accomplish another straightforward task.

After SSO integration, other options become available, including:

- Member-only discounts
- Restriction/blocking for entry to a member-only award; and
- Member status workflows

#### Pre-Populate Data (AMS to OpenWater)

Your AMS already contains data entrants could use in their application form. This includes common information such as company name, job title, or something as simple as an address. And, by integrating your AMS with OpenWater, you can prefill the information you already have for users, saving them time and frustration.

All AMS fields can be mapped on a one-to-one basis with OpenWater fields. Where one-to-one correlation isn't possible, we support custom mappings to further simplify the entry process for users. Some of the custom mappings we've previously implemented include:

- Membership Status to an Individual's Company's Membership Status instead of their own
- Custom fields (e.g. School Name) to the Company/Organization Field if entrants are all schools
- CV/Resume to the Photo field

The possibilities are limitless and can be customized to suit the unique needs of your organization.



Nominators often use OpenWater to nominate a member of their organization for an award. In some cases, members must be of a certain standing or meet other requirements to qualify for the award.

In the past, staff members were required to manually check each entry for these requirements by comparing the AMS to each nomination. OpenWater automates the process by allowing nominators to find the member they wish to nominate in the system itself. Because an organization can restrict eligible members, there's no need to waste time and money paying a staff member to manually check each entry any longer.



You can push data from OpenWater into the AMS whenever you want. One reason you may want to do this is to add information gained in OpenWater to AMS member profiles. For example, if you charge an entry fee and want the transaction information pushed into profiles for reporting purposes, you can do so through integration. Other useful examples of activity push include organizations that want to know which people or companies have applied to their awards in the past or those who want to flag previous winners.

OpenWater is easily customizable to suit any data-driven needs from our software to your AMS.
